# Items to note:

- We all take pride in the beautiful rural setting of the Town of Berlin. Let's all
  do our part to keep our own properties well kept, free of clutter and debris,

- There will be a possible change in the day of the week for garbage pick-up. Waste management is thinking of moving the pick-up day to Wednesday to better serve our town and hopefully have less "missed garbage" days with more trucks available for the route. We will keep you posted and alerted to the change if any as it comes. But we just wanted to give you a heads up that the problem is trying to be addressed.
- Please don't throw anything in your garbage containers that is not supposed
  to be in there. We did have a few incidents of small refrigeration units
  being thrown in the garbage and Waste Management was able to catch,
  identify where they came from, and the issue was addressed. This just costs
  all the town residents money and it is your responsibility to dispose of these
  items yourself.
- As always, when the snow does come, please note that it is unlawful to plow snow from your property across a town or county road. This is not only unlawful, but just dangerous as well.
- Bugtussel Tower- I have been in contact with our Bugtussel rep and this is what he gave me for an update on the project; they are waiting for regulatory approval on October 22, which should happen. Then depending on the collaboration between some "other services" that could use the tower, they will begin construction either this fall yet or right away in the spring. We will keep on this, and you updated as well.
